Mayor Tuggle opened a duly advertised public hearing at 7:05 PM on the request by Dominion Energy Services on behalf of Atlantic Coast Pipeline, LLC, that would, if approved, lease approximately 49 acres (Tax Map. No. 96-5-15) commonly referred to as Lot 15 Brockman Park Drive, Amherst, Virginia 24521, to Atlantic Coast Pipeline, LLC, for a period of two years, along with possible extensions, together with all improvements, rights, privileges, ingress and egress, and other easements appurtenant thereto, for the purposes of a contractor office, shop, equipment and materials storage yard and for such other related purposes Company may determine from time to time in the future.

Eleanor Amidon, 931 Tanbark Drive, Afton, Nelson County, VA 22920, came forward in opposition of the request by Dominion Services on behalf of Atlantic Pipeline, LLC, stating her resistance to the pipeline for 4-5 years and expressing concerns that the lease lets Dominion do whatever it wants leaving the Town with the cleanup, absolving them of any responsibility for any mess they make. She implored council, for the Town's sake, to have an attorney who is familiar with this type of law, to look over the lease before signing.

Barbara Pryor, 2464 Puppy Creek Road, Amherst, VA, came forward in opposition of the request by Dominion Services on behalf of Atlantic Pipeline, LLC, expressing concerns of its close proximity to Fairmont Nursing Home and pipeline workers are not known to be the safest workers in the world, and asked council to stand against Dominion's plan in the interest of fighting climate change.

There being no one else present who wished to speak on the matter, the public hearing closed at 7:13 PM.

Town Council Comments 08/14/2019

My name is Barry Thompson, and I live within the town limits at 287 Waugh's Ferry Road. I have a couple of issues on my mind other than your inappropriate removal of Janice Wheaton from Council.

First, I would like to share my thoughts regarding your decision to spend \$500,000 on a Police Station. It has barely been three years since moving into the current town hall which was supposed to accommodate the current and future needs of the Town. At that time the decision was made that the Police Dept. could be adequately accommodated in the new building. Otherwise that would have been the perfect time for them to occupy the old town hall. It was handicapped accessible and had a recently installed HVAC system and roof and could have been used as is to meet their needs. Mr. Watts, former Police Chief, was on council then and evidently said it wasn't needed. Instead the building was sold for \$120,000. Now Mr. Watts is saying it is needed, so here we are three years later, at an additional cost to the taxpayers of \$380,000.

I understand that Mr. Watts' son is a town policeman, and to me that creates a conflict of interest as a member of council. I realize that the police chief handles affairs of the Dept. but nothing gets done or appropriated without the approval of Council. I just don't see how Mr. Watts can participate in discussions regarding the Police Dept. and vote on budget or personnel issues without some degree of bias. There is opportunity here for nepotism.

Now what about the Town Park? Other than a zoning change, I don't believe there has been any type of Public Hearing regarding the need for a park. Nor, can I find anywhere that Council has had any feasibility discussions about a need for a park, and if so what will it provide. If you were going to have a park, you should have decided ahead of time what it would provide and then looked for a parcel that would satisfy those requirements. Instead, you bought a parcel without public input regarding the need as well as what it would provide. There is not much you can do with this isolated parcel in a flood plain which is at the end of a

single lane road that is not state maintained. This is not a case of where if you buy it, they will come. I think the only way they come is in your dreams. Let's not spend good money after bad. This would not have been a good deal even if it was donated, certainly not at a cost of \$35,000 before the cost of any necessary improvements and ongoing upkeep.

I think Council needs to be addressing the cost of water which is high compared to other localities, and is an expense that is affecting almost all town residents. The water system just doesn't have a large enough customer base to reasonably spread the cost of infrastructure upgrades in the rate structure. Rather than trying to recover all this cost through rates, Council should consider using other revenues to mitigate the rates. Nothing in the Town code prevents this. I think residents would vote for this use of their funds over spending more money on things such as an unwanted Town Park and an expensive Police Station.

The way you have been spending money is a reflection of the fact that you have not had to meet a payroll. If so, you might have been a bit more cautious. The Town is fortunate to have a high percentage of meals tax revenue providers which puts it in a positive cash position. Other than water, sewer, police and the support thereof, the Town really doesn't have required cash obligations, so don't be looking for ways to spend money just because you have it. Spend it because of a need, not a want.

As a parting thought, you ought to discuss merging the Police Dept. into the Sheriff's Dept. Appomattox is a bigger town than Amherst and they do not have a police dept. Their town has an arrangement with the Sheriff's Dept. that meets the protection requirements of the town with one law enforcement agency serving the county as a whole. I have heard this idea discussed by several in the town, and who knows, there might be a consensus on this. Let's find out.

Anyway, 2020 is the next election where the voters can hold three of you accountable for your past votes and how you vote on whether or not to change the Town Charter plus other issues that arise over the next year.

Remarks from the Mayor Town Council Meeting on August 14, 2019

Thank you all for coming tonight to speak to the Council. We are grateful for your participation and your attendance.

We have heard everything that was expressed this evening, and we want to Thank you for your feedback and your concern. The process of governance requires an active citizenry to work as it should. Your concern, attention and action are welcomed by the Council. We hope that you continue to attend and to voice your thoughts.

Please be assured that the Council has had, and will continue to have, nothing but the best interests of the citizenry and the Town. The actions that have been taken are legal and ethical and while we know that there are those who do not agree with them, they were in all ways, legal and ethical decisions.

I want to take a minute of personal privilege to dispel two particular misconceptions that have been repeated in public.

First, the expulsion, while unusual, is neither illegal nor unprecedented. In a 2014 State Attorney General Advisory Opinion to the Town of Haymarket – which along with several other Towns in the state has the same provision in their Charter- the AG notes that "a legislative body's discipline of one of its members is a core legislative act" and this has been supported in multiple cases over time. Additionally, this same power is held by both the Virginia General Assembly and Congress. If you have any questions about this issue, I encourage you to read the entire opinion. It is comprehensive and clear.

Second, the closed session has been questioned as to whether it would be a violation of FOIA since a Council member is not an employee. The Virginia FOIA Council offers advisory opinions to governments and interested citizens regarding FOIA practices. In 2003, the FOIA Council rendered an opinion addressing this question regarding a School Board. In the opinion, they make the distinction clear that the determining factor for whether the exemption can be used is whether the body has the right to discipline the member. If the 'public body retains some level of control over the individual whom it wishes to discuss,' then the closed session may be used. Again, if you have questions about this, please read the full opinion. Staff will be happy to provide a link to anyone who is interested.

We know that there are citizens of the Town that are not happy with this decision, and that there are some that are not happy with us. We know that you want more information. The concern of Council about our obligation to maintain our Code of Ethics has put us in a problematic position in regard to satisfying the very real and reasonable desire for information. It has been a very hard road to walk for the last month. But at the end of every day, Council has stayed true to their commitment to handle this with the highest level of legal and ethical behavior. It would have been easier on Council's part to say more. However, that would have been a violation of the Council's Code of Ethics.

We ask for your patience, your grace, and your prayers for the Town.
