# Town of Amherst, Virginia Community Profile

The Town of Amherst is located along U.S. Route 29 between Lynchburg and Charlottesville, Virginia and is the county seat of Amherst County. The town encompasses approximately 5 square miles and population within the Town's corporate limits is about 2,231 per the 2010 census.


Centrally located within the Commonwealth of Virginia, the Town is situated at the foot of the Blue Ridge Mountains within 25 miles of the Blue



Ridge Parkway and the Appalachian Trail. The Jefferson National Forest and related mountain campgrounds are less than 20 miles from the Town.

Amherst celebrated the 100th anniversary of its incorporation in 2010. The town developed around the courthouse and railroad depot. Four Amherst County schools are located in or near the Town as well as virtually all county offices including the library and museum. A branch of the Central Virginia Community College is also located in town and Sweet Briar College borders the Town's corporate limits.

Urban amenities, cultural opportunities and sporting events are readily available in Lynchburg (15 miles and 20 minutes) and Charlottesville (52 miles and 56 minutes). For transportation to other east coast locations, Interstates I-81 and I-64 are within 40 miles and Amtrack service is within 15 miles.



#### The Government

The Town of Amherst has a five-Town Council member and independent mayor, and all are currently elected on a 2-year concurrent cycle in the fall of every even numbered year. However, the petitioning the Virginia Town is General Assembly to approve a implementing charter change stagaered terms. The Town Council sets the policies for the operation of the Town's government. The previous Town Manager served for 25 years.



#### **Position Profile**

The Town Manager leads the Town's senior management team and is recognized as a community leader. The Town of Amherst has a good residential and retail/commercial mix which creates high and diverse customer service expectations. The Town is seeking an outstanding leader who has the experience, talent and professional commitment, vision and leadership to guide the short- and long-range provision of services to the residents and business persons of the Town of Amherst.

Primary services provided by the Town include 24-hour police protection, widespread water and sewer service, contracted garbage pick-up service, land use planning through the administration of subdivision and zoning regulations and a focus on downtown development.

Key attributes of the successful candidate include a highly developed professional knowledge and leadership skills, managerial and administrative competence, maturity of judgment, strong personal leadership and relationship skills, high ethical standards, and the ability to communicate effectively and positively with the organization. It is expected that the Town Manager will have a strong commitment to customer service.

Residence in the corporate limits of the Town is required within one year of employment. A job description is attached.

### Compensation

The compensation package for the Town Manager will be market competitive and depend upon experience and qualifications of the individual selected. Reasonable relocation expenses are available, if needed. The anticipated hiring range is \$75,000 to \$90,000 per year. A generous benefit package includes: retirement and life insurance through the Virginia Retirement System (VRS), 100% Town funded medical and dental coverage for the employee with optional dependent coverage paid by the employee, access to a 457 Deferred Compensation Plan, paid holidays, vacation and sick leave and other benefits such as a mobile telephone allowance and use of a pool car for Town business.
