- 1. Purchase Approval for new Police Car (Pgs. 34-39) Sara Carter- Council gave purchase approval for one new police car at the June 9, 2021 meeting. With additional money for lost revenue available through ARPA funds, staff recommends that Council authorize purchase of a second car. This will allow one car to be retired, and a second to become a spare car. Purchase approval will be for a car, equipment, and installation. Some equipment will be reused from the retired car.
- **2.** Purchase Approval for Waste Flow Meter (Pgs. 40-41)- Gary Williams- This purchase approval is for a flow meter at the wastewater treatment plant that measures flow between the upper and lower portions of the plant for reporting and monitoring purposes.
- **3.** Set Public Hearing for Sale of Pump Station Lot between Whitehead Drive and Maple Lane and Fee-Simple Road Lot (Pgs. 42-43) Sara Carter- The Town owns an approximate one acre lot, which contains an abandoned pump station as well as water and sewer lines. Additionally, the Town owns a strip of land from Whitehead Drive to the pump station that is intended to be a road. There are parties interested in purchasing both properties. In order to sell these lots, the Town must hold a public hearing. Staff requests that the Council set a public hearing for next month's meeting to consider sale of the properties. Staff further recommends that upon the sale, that an easement would be maintained for all Town infrastructure on the lots.
- **4.** Update and Consideration on Purchase for a Bucket Truck or Lift (Pgs. 44-67) Charles Thompson and Sara Carter-Council requested staff review options for a bucket truck or boom lift for the Maintenance staff and provide a recommendation and pros and cons for each.

Town Manager Carter gave a brief report on a proposed amendment to Chapter 8 of the Town of Amherst Code, creating a new Article IX Cigarette Tax. If approved, the new article would levy an excise tax equivalent to \$0.27 per package containing 25 or fewer cigarettes. The new article also provides definitions, methods of collection, stamp requirements, violations and penalties, and other provisions related to the levy of this tax. Staff recommends adoption of the proposed amendment at counsel's next regular meeting on July 14, 2021, with an effective date of September 1, 2021, or later.

Vice Mayor Carton opened a duly advertised public hearing at 7:04 P.M. on the proposed amendment to Chapter 8 of the Town of Amherst Code, creating a new Article IX Cigarette Tax. There being no one present in person or electronically who wished to speak on the proposed Cigarette Tax, the public hearing closed at 7:04 P.M. After discussion, the matter was deferred to council's next regular meeting on July 14, 2021, as recommended by staff.

The purpose of the meeting was for Town Council to discuss potential uses of anticipated American Rescue Plan Act funds (ARPA) to the Town of Amherst.

Town Manager Carter reported on the ARPA anticipated revenue, the Federal Government's interim final rule, and possible use of ARPA funds.

The Town is set to receive 2.2 million from the ARPA to be delivered in two traunces, the first to be received June 28, 2021, with the second one year later. Costs must be incurred by the end of 2024 and expended by the end of 2026.

Per the interim final rules, ARPA money cannot be used for debt service, pensions or establishing reserves but can be used to cover responses to the public health emergency, premium pay for workers who performed essential service during the pandemic, revenue loss, and critical infrastructure. Revenue loss can be used for a "salary swap" where salaries are paid using the federal money. The "swap" would then allow the Town to complete other projects not related to wastewater, such as purchase of a new police vehicle, purchase of either a bucket or lift vehicle, or in other ways deemed appropriate. Although ARPA money could be used for assisting individual households, it was noted that the town government does not have a social service department to help facilitate the outreach it would involve. Because the Town is not considered a qualified census tract, the Town is not able to facilitate the use of ARPA money for playgrounds or pools.

Further discussion on the matter was deferred.

There being no further business, the meeting adjourned at 7:12 P.M., until July 14, 2021, at 7:00 p.m.

# Stand Out Details of Monthly Operations,

- June was a relatively quiet month with no significant problems or issues occurring at the Towns plants. And while the State, as well as the Country, begins to open back up, many State agencies are still holding web meets. And much of the buzz in June was about EPA's revisions of the Lead and Copper Rule and continued PFAS review for regulation purposes.

# Is my water safe?

We are pleased to present this year's Annual Water Quality Report (Consumer Confidence Report) as required by the Safe Drinking Water Act (SDWA). This report is designed to provide details about where your water comes from, what it contains, and how it compares to standards set by regulatory agencies. This report is a snapshot of last year's water quality. We are committed to providing you with information because informed customers are our best allies.

# Do I need to take special precautions?

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. EPA/Centers for Disease Control (CDC) guidelines on appropriate means to lessen the risk of infection by Cryptosporidium and other microbial contaminants are available from the Safe Water Drinking Hotline (800-426-4791).

# Where does my water come from?

The Town of Amherst Water Treatment Plant (WTP) receives there raw water from the Buffalo River. During times of drought conditions the Mill Creek Reservoir in Amherst County is used to supplement the river.

The raw water is pumped from the Buffalo River to the WTP. A chemical coagulate is added to the water to assist the organic matter to stick together, then the water flows to sedimentation basin at which point the floc (organic matter that has stuck together) has time to settle to the bottom of the basin. The water at the top of sedimentation basin will flow on top of the filters, where it is filter to the clearwell. Once the finish water is in the clearwell it is then pumped out to Waugh's Ferry Tank and Union Hill Tank. Each of these tank's will hold 1 MG of water for distribution.

# Source water assessment and its availability

A source water assessment was performed by the Office of Drinking Water in April 2003.

# Why are there contaminants in my drinking water?

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. More information about contaminants and potential health effects can be obtained by calling the Environmental Protection Agency's (EPA) Safe Drinking Water Hotline (800-426-4791). The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity:

microbial contaminants, such as viruses and bacteria, that may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife; inorganic contaminants, such as salts and metals, which can be naturally occurring or result from urban stormwater runoff, industrial, or domestic wastewater discharges, oil and gas production, mining, or farming; pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff, and residential uses; organic Chemical Contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, and septic systems; and radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities. In order to ensure that tap water is safe to drink, EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. Food and Drug Administration (FDA) regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

# How can I get involved?

The Town of Amherst has monthly council meetings held on the second Wednesday of each month at 7pm in Council Chambers and are also live stream to youtube.

The Town of Amherst Water Treatment Plant is always looking for homes that want to be added to Lead & Copper sampling sites.

# **Description of Water Treatment Process**

Your water is treated by filtration and disinfection. Filtration removes particles suspended in the source water. Particles typically include clays and silts, natural organic matter, iron and

manganese, and microorganisms. Your water is also treated by disinfection. Disinfection involves the addition of chlorine or other disinfectants to kill bacteria and other microorganisms (viruses, cysts, etc.) that may be in the water. Disinfection is considered to be one of the major public health advances of the 20th century.

# Water Conservation Tips

Did you know that the average U.S. household uses approximately 400 gallons of water per day or 100 gallons per person per day? Luckily, there are many low-cost and no-cost ways to conserve water. Small changes can make a big difference - try one today and soon it will become second nature.

- Take short showers a 5 minute shower uses 4 to 5 gallons of water compared to up to 50 gallons for a bath.
- Shut off water while brushing your teeth, washing your hair and shaving and save up to 500 gallons a month.
- Use a water-efficient showerhead. They're inexpensive, easy to install, and can save you up to 750 gallons a month.
- Run your clothes washer and dishwasher only when they are full. You can save up to 1,000 gallons a month.
- Water plants only when necessary.
- Fix leaky toilets and faucets. Faucet washers are inexpensive and take only a few minutes to replace. To check your toilet for a leak, place a few drops of food coloring in the tank and wait. If it seeps into the toilet bowl without flushing, you have a leak. Fixing it or replacing it with a new, more efficient model can save up to 1,000 gallons a month.
- Adjust sprinklers so only your lawn is watered. Apply water only as fast as the soil can absorb it and during the cooler parts of the day to reduce evaporation.
- Teach your kids about water conservation to ensure a future generation that uses water wisely. Make it a family effort to reduce next month's water bill!

# **Source Water Protection Tips**

Protection of drinking water is everyone's responsibility. You can help protect your community's drinking water source in several ways:

- Eliminate excess use of lawn and garden fertilizers and pesticides they contain hazardous chemicals that can reach your drinking water source.
- Pick up after your pets.

- If you have your own septic system, properly maintain your system to reduce leaching to water sources or consider connecting to a public water system.
- Dispose of chemicals properly; take used motor oil to a recycling center.
- Volunteer in your community. Find a watershed or wellhead protection organization in your community and volunteer to help. If there are no active groups, consider starting one. Use EPA's Adopt Your Watershed to locate groups in your community, or visit the Watershed Information Network's How to Start a Watershed Team.
- Organize a storm drain stenciling project with your local government or water supplier. Stencil a message next to the street drain reminding people "Dump No Waste - Drains to River" or "Protect Your Water." Produce and distribute a flyer for households to remind residents that storm drains dump directly into your local water body.

# **Results of Cryptosporidium monitoring**

The Town of Amherst completed its Round 2 Source Water Monitoring for Cryptosporidium in March 2021. Monitoring was a 24-month sampling and testing project of the water plant's raw water influent per 12VAC5-590 420 B 3 c.

The highest annual mean Cryptosporidium concentration for the Round 2 Source Water samples was 0.025 oocytes per Liter. According to the LT2 Rule, the bin classification table in 12VAC5-590 420 B 3 c was below the 0.075 oocytes per Liter and maintained a Bin Classification 1. Current treatment is adequate for treating the source water.

# **Additional Information for Lead**

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Town of Amherst Water Treatment Plant is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Information on lead in drinking water, testing methods, and steps

you can take to minimize exposure is available from the Safe Drinking Water Hotline or at http://www.epa.gov/safewater/lead.

# **Additional Information for Arsenic**

While your drinking water meets EPA's standard for arsenic, it does contain low levels of arsenic. EPA's standard balances the current understanding of arsenic's possible health effects against the costs of removing arsenic from drinking water. EPA continues to research the health effects of low levels of arsenic which is a mineral known to cause cancer in humans at high concentrations and is linked to other health effects such as skin damage and circulatory problems.

# Water Quality Data Table

In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of contaminants in water provided by public water systems. The table below lists all of the drinking water contaminants that we detected during the calendar year of this report. Although many more contaminants were tested, only those substances listed below were found in your water. All sources of drinking water contain some naturally occurring contaminants. At low levels, these substances are generally not harmful in our drinking water. Removing all contaminants would be extremely expensive, and in most cases, would not provide increased protection of public health. A few naturally occurring minerals may actually improve the taste of drinking water and have nutritional value at low levels. Unless otherwise noted, the data presented in this table is from testing done in the calendar year of the report. The EPA or the State requires us to monitor for certain contaminants less than once per year because the concentrations of these contaminants do not vary significantly from year to year, or the system is not considered vulnerable to this type of contamination. As such, some of our data, though representative, may be more than one year old. In this table you will find terms and abbreviations that might not be familiar to you. # TOWN OF AMHERST TOWN AND COUNTY PROJECTS COMMITTEE MINUTES June 16, 2021 6:00 PM

A meeting was called to order by Kenneth Bunch, Chairman of the Town and County Projects Committee on June 16, 2021, at 6:10 PM in the County Administration Public Meeting Room, County Administration Building (153 Washington Street). It was noted that the following were present in person as follows:

Present from the County of Amherst were County Supervisors Jimmy Ayers and Claudia Tucker.

Present from the Amherst Life Savings Crew were Scott Bryant, Charlie Goodin and Glenda Hash.

Vicki Hunt, Clerk of Council, was also present.

Mr. Bryant reported that Amherst Life Saving Crew is preparing to dissolve its corporate structure, ceasing to operate as an entity separate from the county because of the limited number of people available to handle the EMS calls. Their articles of incorporation require distribution of remaining assets to the Town of Amherst and the County of Amherst. Issues presented by the Lifesavings Crew members are how to equally distribute the assets. Mr. Bryant wishes for the Town to retain an interest in the oversight of the building, and it's continued use as an EMS site. Because the assets were mostly derived from citizens on the County's north end, the group hopes that the service and assets would remain concentrated in that area. While agreeing that it would not be an equal distribution, Ms. Hash opined that the building and vehicles should go to the County and all monies to the Town.

The Town's Committee Members and Supervisors from Amherst County reviewed and discussed the information from the Amherst Lifesavings Crew and any foreseen issues that may arise from the planned dissolution and distribution of remaining assets. After dissolution, the County intends to fold personnel and resources into Amherst County's public safety department. Ms. Turner read an amendment to the bylaws raising the question as to whether it is in fact an equal distribution or a distribution of all assets jointly to the parties thereby making both government entities equal owners and partners in the oversight of the building and all monies associated with the distribution. Town Committee Members agreed that the Town did not have the resources to govern the operation of an EMS but committee members want to retain equal control on the future of the building and its intended EMS purpose and the monies associated with the distribution.

It was agreed that all parties will discuss the amendment to the bylaws with their respective counsel and board members. Further discussion was deferred to a date to be determined.

The meeting concluded at 7:10 PM.

Code of Virginia Title 15.2. Counties, Cities and Towns Subtitle II. Powers of Local Government Chapter 18. Buildings, Monuments and Lands Generally Article 1. Purchase, Sale, Etc., of Real Property

# § 15.2-1800. Purchase, sale, use, etc., of real property

A. A locality may acquire by purchase, gift, devise, bequest, exchange, lease as lessee, or otherwise, title to, or any interests in, any real property, whether improved or unimproved, within its jurisdiction, for any public use. Acquisition of any interest in real property by condemnation is governed by Chapter 19 (§ 15.2-1901 et seq.). The acquisition of a leasehold or other interest in a telecommunications tower, owned by a nongovernmental source, for the operation of a locality's wireless radio communications systems shall be governed by this chapter.

B. Subject to any applicable requirements of Article VII, Section 9 of the Constitution, any locality may sell, at public or private sale, exchange, lease as lessor, mortgage, pledge, subordinate interest in or otherwise dispose of its real property, which includes the superjacent airspace (except airspace provided for in § 15.2-2030) which may be subdivided and conveyed separate from the subjacent land surface, provided that no such real property, whether improved or unimproved, shall be disposed of until the governing body has held a public hearing concerning such disposal. However, the holding of a public hearing shall not apply to (i) the leasing of real property to another public body, political subdivision or authority of the Commonwealth or (ii) conveyance of site development easements, or utility easements related to transportation projects, across public property, including, but not limited to, easements for ingress, egress, utilities, cable, telecommunications, storm water management, and other similar conveyances, that are consistent with the local capital improvement program, involving improvement of property owned by the locality. The provisions of this section shall not apply to the vacation of public interests in real property under the provisions of Articles 6 (§ 15.2-2240 et seq.) and 7 (§ 15.2-2280 et seq.) of Chapter 22.

C. A city or town may also acquire real property for a public use outside its boundaries; a county may acquire real property for a public use outside its boundaries when expressly authorized by law.

D. A locality may construct, insure, and equip buildings, structures and other improvements on real property owned or leased by it.

E. A locality may operate, maintain, and regulate the use of its real property or may contract with other persons to do so.

Notwithstanding any contrary provision of law, general or special, no locality providing access and opportunity to use its real property, whether improved or unimproved, may deny equal access or a fair opportunity to use such real property to, or otherwise discriminate against, the Boy Scouts of America or the Girl Scouts of the USA. Nothing in this paragraph shall be construed to require any locality to sponsor the Boy Scouts of America or the Girl Scouts of the USA, or to exempt any such groups from local policies governing access to and use of a locality's real property. The provisions of this paragraph applicable to a locality shall also apply equally to any local governmental entity, including a department, agency, or authority. F. This section shall not be construed to deprive the resident judge or judges of the right to control the use of the courthouse.

G. "Public use" as used in this section shall have the same meaning as in § 1-219.1.

Re:	Information regarding bucket trucks and lifts

Mr. Thompson was tasked with revieing options for bucket trucks and lifts for Council to replace the existing bucket truck. The existing truck is a 1995 model and is significantly larger than what the Town needs and because of its size, is only good for one use. Additionally, there will be a significant cost for the continued use of this truck. The best option for the Town, if price were not an issue, would be a one-ton bucket truck with a forty-foot reach. This is a size truck that could be used for a variety of purposes, including the bucket reach, towing the jetter, and general purpose. However, upon research, finding used trucks of this type is difficult, with most used models having in excess of 100,000 miles. Lifts of varying types were also researched.

## Mr. Thompson's conclusion was as follows:

My research is completed on the replacement of the bucket truck. New and used trucks as well as I towable lifts have been priced. The reach should a minimum of 40 feet. Expenses could be from 30,000 to 160,000, I recommend the purchase of a towable lift because a new or used truck cannot be justified if it was available. A towable lift is being is being rented for 300.00 a day which does not include delivery or pickup. The current truck has no other value to the department and can be sold toward the purchase.

Mr. Thompson has obtained a variety of quotes for Council so that they may have a better idea of what is available. In sum, he found:

- A new bucket truck of the appropriate type would cost approximately \$123,000.
- A used buck truck of the appropriate type could typically have 100,000 miles and cost \$70,000.
- A new aerial lift that would tow behind a truck ranges in price from \$18-30,000. The best suited size and type is currently approximately \$30,000.

## AN ORDINANCE TO AMEND THE CODE OF THE TOWN OF AMHERST BY ADDING SECTION 8.365 THROUGH 8.381 OF CHAPTER 8, ARTICLE IX OF THE TOWN CODE, THE AMENDED CODE REFERRING TO TAXATION

Be it Ordained by the Council of the Town of Amherst:

*That Sec.* 8.365 *through Sec.* 8.381 *of the Code of the Town of Amherst are hereby added to read as follows:* 

## ARTICLE IX. CIGARETTE TAX

## Sec. 8-365. Definitions.

The following words and phrases, when used in this article, shall, for the purposes of this article, have the following respective meanings except where the context clearly indicates a different meaning:

*Cigarette* means any roll of any size or shape for smoking, whether filtered or unfiltered, with or without a mouthpiece, made wholly or partly of cut, shredded or crimped tobacco or other plant or substitute for tobacco, whether it is flavored, adulterated or mixed with another ingredient, if the wrapper or cover is made of any material other than leaf tobacco or homogenized leaf tobacco, regardless of whether the roll is labeled or sold as a cigarette or by any other name.

*Dealer* means every manufacturer, jobber, wholesale dealer, or other person who supplies a seller with cigarettes.

Package means any container, regardless of the material used in its construction, in which separate cigarettes are placed without such cigarettes being placed into any container within the package. Packages are those containers of cigarettes from which individual cigarettes are ordinarily taken when they are consumed by their ultimate user. Ordinarily, a package contains twenty (20) cigarettes; however, the term "package" includes those containers in which fewer or more than twenty (20) cigarettes are placed.

*Person* means any individual, partnership, society, association, joint stock company, corporation, estate, receiver, trustee, assignee, referee, or any other person acting in a fiduciary or representative capacity, whether appointed by a court or otherwise, and any combination of individuals.

*Purchaser* means every person to whom title to any cigarettes is transferred by a seller within the jurisdictional limits of the town.

Sale means every act or transaction, irrespective of the method or means employed, including the use of vending machines and other mechanical devices, whereby title to any cigarettes is transferred from the seller to any other person within the jurisdictional limits of the town.

*Seller* means every person who transfers title to any cigarettes or in whose place of business title to any cigarettes is transferred, within the jurisdictional limits of the town, for any purpose other than resale.

*Stamp* means a small gummed piece of paper or decal to be sold by the treasurer and to be affixed to every package of cigarettes sold at retail in the town, and also any insignia or symbols printed by meter machine upon any such package under the authorization of the treasurer.

Treasurer means the treasurer of the town and any of his or her duly authorized deputies and agents.

## Sec. 8-366. Registration required.

Each distributor, wholesaler, vendor, retailer, or other person selling, storing, or possessing cigarettes within or transporting cigarettes within or into the town for sale or use shall first register with the treasurer of the town. The application form, which shall be supplied upon request, shall require such information relative to the nature of the business engaged in by the applicant as the treasurer deems necessary for the administration and enforcement of this article. Any applicant whose place of business and residence is outside the town shall automatically, by filing his application, submit himself to the town's legal jurisdiction and appoint the town administrator as his agent for any service of lawful process. A copy of any such process served on the town administrator shall be sent forthwith by registered mail to the distributor, wholesaler, vendor, retailer, or other person.

## Sec. 8-367. Levied; amount.

There is hereby levied and imposed by the town, upon each and every sale of cigarettes, an excise tax of one and thirty-five hundredths (1.35) cents per cigarette sold within the town (i.e., twenty-seven (27) cents per pack), the amount of such tax to be paid by the seller, if not previously paid, in the manner and at the time provided for in this article.

## Sec. 8-368. Method of payment.

- (a) The tax imposed by this article shall be paid by affixing or causing to be affixed a stamp or stamps, of the proper denominational or face value, to each and every package of cigarettes sold within the town, in the manner and at the time or times provided for in this article. Every dealer and every seller in the town, once registered, shall have the right to buy such stamps from the town treasurer and to affix the same to packages of cigarettes as provided in this article.
- (b) The treasurer may permit the payment in advance of the tax levied and imposed by this article by the method of placing imprints of the stamps upon original packages by the use of meter machines, in lieu of the method of paying such tax by the purchase and affixing of gummed stamps, and may prescribe and enforce the necessary regulations setting forth the method to be employed and the condition to be observed in the use of such meter machines.

## Sec. 8-369. Preparation and sale of stamps.

For the purpose of making stamps available for use, the treasurer shall prescribe, prepare, furnish and sell stamps of such denominations and in such quantities as may be necessary for the payment of the taxes imposed by this article. In the sale of such stamps, the town treasurer shall allow a discount of one-tenth (0.10) of a cent per cigarette (i.e., two (2) cents per pack) to cover the costs which will be incurred in affixing the stamps to packages of cigarettes. In the event the printing by an authorized meter machine is used in lieu of gummed stamps, there shall be allowed a discount of six (6) percent of the denominational or face value of the imprints of such stamps so printed by such meter machine to cover the costs incurred in printing such imprints.

## Sec. 8-370. General duties of dealers and sellers with respect to stamps.

- (a) Every dealer in cigarettes is hereby required and it shall be his duty to purchase such stamps, at the office of the town treasurer, as shall be necessary to pay the tax levied and imposed by this article, and to affix or cause to be affixed a stamp or stamps of the monetary value prescribed by this article to each package of cigarettes prior to delivery or furnishing of such cigarettes to any seller. Nothing herein contained shall preclude any dealer from using a stamp meter machine in lieu of gummed stamps to effectuate the provisions of this article.
- (b) Every seller shall examine each package of cigarettes prior to exposing the same for sale, for the purpose of ascertaining whether such package has the proper stamps affixed thereto or imprinted thereon, as provided by this article. If, upon such examination, unstamped or improperly stamped packages of cigarettes are discovered, the seller, where such cigarettes were obtained from a dealer, shall immediately notify such dealer, and upon such notification, such dealer shall forthwith either affix to or imprint upon such unstamped or improperly stamped packages the proper amount of stamps, or shall replace such packages with others to which stamps have been properly affixed or imprinted thereon.
- (c) Should a seller obtain or acquire possession of, from any person other than a dealer, any unstamped or improperly stamped cigarettes, such seller shall forthwith, before selling or offering or exposing such cigarettes for sale in the town, purchase and affix or cause to be affixed to such packages of cigarettes the proper stamps, or the markings of a meter machine, covering the tax imposed by this article.
- (d) In the event any seller elects to purchase and affix stamps or imprints of a meter machine, before offering cigarettes for sale, any dealer delivering and furnishing cigarettes to such seller shall not be required to purchase and affix such stamps or imprints to such cigarettes so sold or furnished; provided that any such dealer shall, on the day after such delivery and furnishing, file with the treasurer a copy of the delivery memorandum showing the name and address of the seller and the quantity and type of cigarettes so delivered and furnished.

## Sec. 8-371. Visibility of stamps or meter markings.

Stamps or the printed markings of a meter machine shall be placed upon each package of cigarettes in such manner as to be readily visible to the purchaser.

## Sec. 8-372. Altering design of stamps.

The treasurer may, from time to time, and as often as he or she may deem advisable, provide for the issuance and exclusive use of stamps of a new design and forbid the use of stamps of any other design.

## Sec. 8-373. Refund for unused stamps or meter imprints.

(a) Should any person, after acquiring from the town treasurer any stamps provided for in this article, cease to be engaged in a business necessitating the use thereof, or should any such stamps become mutilated and unfit for use, other than by cancellation as provided in this article, such person shall be entitled to a refund of the denominational or face amount of any stamps so acquired and not used by him, less five (5) percent of the denominational or face amount thereof, upon presenting such stamps to the treasurer and furnishing the treasurer with an affidavit showing, to his satisfaction, that such stamps were acquired by such person

and have not in any manner been used and the reason for requesting such refund. In the case of any authorized meter machine, should any imprints of such machine theretofore paid for not be used, such person shall, upon furnishing the treasurer with a similar affidavit, be entitled to a refund of the denominational or face amount thereof, less six (6) percent of the denominational or face amount of such imprints of such machine not so used.

- (b) All refunds for unused and mutilated stamps and for nonuse of imprints of stamps by meter machines provided for under this section are hereby authorized to be made on vouchers approved by the treasurer and, when made, the same shall be charged against the sums collected for the sale of such stamps and for the use of such imprints.

## Sec. 8-374. Seizure and sale of unstamped cigarettes.

- (a) Whenever the treasurer shall discover cigarettes in quantities of more than six (6) cartons within the town which are subject to the tax imposed by this article and upon which the tax has not been paid or upon which stamps have not been affixed or evidence of such tax shown thereon by the printed markings of an authorized meter machine, as this article requires, such cigarettes shall be conclusively presumed for sale or use within the town and the treasurer may forthwith seize and confiscate such cigarettes, if:
  - (1) They are in transit, and are not accompanied by a bill of lading or other document indicating the true name and address of the cosigner or seller and of the cosigner or purchaser, and the brands and quantity of cigarettes so transported; or are in transit and accompanied by a bill of lading or other document which is false or fraudulent in whole or in part; or
  - (2) They are in transit and are accompanied by a bill of lading or other documents indicating:
    - a. A cosignee or purchaser in another state or the District of Columbia who is not authorized by the law of such other jurisdiction to receive or possess such tobacco products on which the taxes imposed by such other jurisdiction have not been paid, and unless the tax of the state or district of destination has been paid and the said products bear the tax stamp of that state or district; or
    - b. A cosignee or purchaser in the Commonwealth but outside the town who does not possess a Virginia sales and use tax certificate, a Virginia retail tobacco license and where applicable, both a business license and retail tobacco license issued by the local jurisdiction of destination; or
  - (3) They are not in transit and the tax has not been paid, nor have approved arrangements for payment been made, provided that this subsection shall not apply to cigarettes in the possession of distributors or public warehouses which have filed notice and appropriate proof with the treasurer that those cigarettes are temporarily within the town and will be sent to cosignees or purchasers outside the town in the normal course of business.
- (b) All cigarettes seized and confiscated according to subsection (a) of this section shall thereupon be deemed to be forfeited to the town and may be sold within a reasonable time thereafter, after proper notice of such seizure is given to the known holders of property interests in the cigarettes. Such notice shall be given to known holders of property interests, if any, by certified mail and by written notice posted on the bulletin board of the court house of the town at least seven (7) days before the date of sale. Such notice shall contain the time and place at which the sale is to occur and procedures for administrative appeal as well as affirmative defenses which may be asserted by such holders. All moneys collected under this section shall be paid to the town treasurer and treated as other taxes collected under this article. No credit from any sale or other disposition shall be allowed toward any tax or penalties owed.

# Sec. 8-375. Seizure and sale of coin-operated vending machines and counterfeit stamp or impression devices.

- (a) Any coin-operated vending machine, in which any cigarettes are found, stored or possessed bearing a counterfeit or false tobacco tax stamp or impression or any unstamped cigarettes, or any cigarettes upon which the tax has not been paid, may be declared contraband property and be subject to confiscation and sale as provided in section 8-180(b). When any such vending machine is found containing such cigarettes, it shall be presumed that such cigarettes were intended for distribution, sale or use therefrom. In lieu of immediate seizure and confiscation of any vending machine used in an illegal evasion of the tax, it may be sealed by appropriate enforcement authorities to prevent continued illegal sale or removal of any cigarettes, and may be left unmoved until other civil and criminal penalties are imposed or waived. Notice requirements shall be the same as if the machine had been seized. Such seal may be removed and the machine declared eligible for operation only by authorized enforcement authorities. Nothing in this section shall prevent seizure and confiscation of a vending machine at any time after it is sealed.
- (b) Any counterfeit stamps or counterfeit impression devices found may also be seized and confiscated.

## Sec. 8-376. Dealers' and sellers' records.

It shall be the duty of every dealer and seller to maintain and keep, for a period of two (2) years, such records of cigarettes sold and delivered by him as may be required by the town treasurer and to make all such records available for examination by such town treasurer, upon demand, at any and all reasonable times.

# Sec. 8-377. Rules and regulations for enforcement and administration of article; examination of books, records, etc.

- (a) The town treasurer may prescribe, adopt, promulgate and enforce rules and regulations relating to the method and means to be used in the cancellation of stamps and to all other matters pertaining to the administration and enforcement of the provisions of this article. It shall be unlawful for any person to fail, neglect or refuse to comply with such rules and regulations.
- (b) The town treasurer may examine books, records and cigarette inventories relevant to the sale of cigarettes in this town on the premises where the cigarettes are stored, displayed or sold or elsewhere in this town. Every agent, seller or dealer shall provide access to the town treasurer for such examination.

## Sec. 8-378. Tax is in addition to other taxes.

The tax levied and imposed by this article shall be in addition to all other taxes of every kind levied and imposed by any other ordinance or law.

## Sec. 8-379. Violations of article—Generally.

- (a) Any person violating any of the provisions of this article shall be guilty of a Class 1 misdemeanor. In addition, any person who shall perform any fraudulent act or fail to perform any act for the purpose of evading the payment of any tax imposed by this article shall be required to pay a penalty in the amount of fifty (50) percent and interest not to exceed three quarters of one percent per month upon any tax found to be overdue and unpaid. Conviction and payment of a fine for such violation shall not relieve any person from the payment of any tax imposed by this article.
- (b) Each violation of, or noncompliance with, any of the provisions of this article shall be and constitute a separate offense and shall subject every person convicted thereof to the penalties prescribed.

## Sec. 8-380. Same—Prohibited acts enumerated.

It shall be unlawful and a violation of this article for any person:

- (1) To perform any act or fail to perform any act for the purpose of evading the payment of any tax imposed by this article or of any part thereof; or for any dealer or seller, with intent to violate any provision of this article, to fail or refuse to perform any of the duties imposed upon him under the provisions of this article or to fail or refuse to obey any lawful order which the treasurer may issue under this article.
- (2) To falsely or fraudulently make, forge, alter or counterfeit any stamp or the printed markings of any meter machine or to procure or cause to be made, forged, altered or counterfeited any such stamp or printed markings of a meter machine or to knowingly and willfully alter, publish, pass or tender as true any false, altered, forged or counterfeited stamp or stamps or printed markings of a meter machine.
- (3) To sell any cigarettes upon which the tax imposed by this article has not been paid and upon which evidence of payment thereof is not shown on each package of cigarettes.
- (4) To reuse or refill with cigarettes any package from which cigarettes, for which the tax imposed has been theretofore paid, have been removed.
- (5) To remove from any package any stamp or the printed markings of a meter machine with intent to use or cause the same to be used after the same have already been used, or to buy, sell or offer for sale or give away any used, removed, altered or restored stamps or printed markings of a meter machine to any person, or to reuse any stamp or printed markings of a meter machine which had theretofore been used for evidence of the payment of any tax prescribed by this article, or, except as to the town treasurer, to sell or offer to sell any stamps or printed markings of a meter machine provided for in this article.

## Sec. 8-381. Same—Presumption of violation by seller.

(a) In the event any package of cigarettes is found in the possession of a seller, without the proper stamps being affixed thereto or without authorized printed markings of a meter machine thereon, and the seller shall be unable to submit evidence establishing that he received such package within the immediately preceding forty-eight (48) hours and that he has not offered the same for sale, the presumption shall be that such package is being kept by such seller in violation of the provisions of this article and shall subject him to the penalties provided for such violation.

- (b) Any cigarettes placed in any coin-operated vending machine located within the town shall be presumed for sale within the town. Any vending machine located within the town containing cigarettes upon which the stamp has not been affixed or containing cigarettes placed so as not to allow visual inspection of the stamp through the viewing areas as provided for by the vending machine manufacturer shall be presumed to contain untaxed cigarettes in violation of this article.
- (c) Any cigarettes, coin-operated vending machines, counterfeit stamps, or other property found in violation of this article shall be declared contraband goods and may be seized by the treasurer. In addition to any tax due, the dealer or other person liable for the tax possessing such untaxed cigarettes shall be subject to civil and criminal penalties herein provided.
- (d) In lieu of seizure, the treasurer may seal such vending machines to prevent continued illegal sale or removal of such cigarettes. The removal of the seal from a vending machine by any unauthorized person shall be in violation of this article. Nothing in this article shall prevent the seizure of any vending machine at any time after it is sealed.
- (e) All cigarette vending machines shall be plainly marked with the name, address and telephone number of owner of the machine.
